5	If minimum value of purchase order is more than Rs. 10,000/- successful bidders will have to provide F.O.R. destination facility. If order value is less than Rs. 10,000/- the respective party has to arrange the supply of the same to the nearest transport office.
6	After supply of the materials/drugs, if some items remained unused and it reaches close to the expiry date, in such case the similar material should be replaced in time having longer expiry date. The concerned office will inform to the party along with the list of drugs to be expired at least two months before.
7	Bidder must upload the valid document of latest price list of concern pharmaceutical companies for which they are bidding. Further, the party must upload authorized dealership/manufacture certificate for same.
8	Any financial issues/consequences arising due to printing error in the price-list (price, units, catalogue, Qty, etc) will be solely the responsibility of the bidder.
9	The items/drugs will be purchased in separate lots as per the requirements and the party will have to supply the same during the validity period at the same cost as mentioned in the tender.

13	The EMD of the successful bidder shall be adjusted towards the security deposits, which shall be kept for a period of 60 days beyond the completion of tender (<i>i.e.</i> , 31/03/2022)

24	The bidder who has offered highest discount percent (%) will be considered as L1 for company and zone/region. L1 will be assigned by considering company and zones.
25	In case of tie between two or amongst more bidders; all will be treated as L1 and veterinary colleges/centres will order proportionally.
26	If there is any difference in the price list of the same company amongst bidders, the latest price list will be considered. However, L1 will be declared on the basis of highest discounts in particular company/region only.
27	The KU has right to reject any or all the offers and invite fresh tender if needed. The KU further reserves the right of selecting the company/materials/quantity to be ordered at a time.
28	For all legal purpose jurisdiction will be Gandhinagar, Gujarat.
29	In case of any dispute, decision of the Vice Chancellor, Kamdhenu University, Gandhinagar, Gujarat will be final and acceptable to all the parties/ bidders.
