With refence to the subject cited above, Polytechnics/Colleges/Institutes of Kamdhenu University were closed and educational activities in all the institutions under Kamdhenu University were suspended due to the current pandemic situation of COVID-19 vide circulars issued earlier by this office cited under reference at Sr no (1).
